### Accident Waiver And Release of Liability:

In consideration of my acceptance for entry in the AUBURN CENTURY for 2012, I hereby waive, release and discharge any and all claims for damages for death, personal injury, or property damage which I may have or which hereafter may accrue to me, as a result of my participation in said event. This release is intended to discharge in advance the promoters, sponsors, and any involved municipalities or other public entities and their respective agents and employees, from and against any and all liabilities arising out of or connected in anyway with my participation in said event, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I further understand that this event will require me to engage in strenuous physical activity at high altitude and in possible adverse weather conditions. I further understand that serious accidents occasionally occur during bicycle riding; and the participants in bicycle riding occasionally sustain mortal or serious physical injury, and/or property damage, as a consequence thereof. Knowing the risk of bicycle riding, nevertheless, I hereby agree to assume these risks and to release and hold harmless all persons or entities mentioned above who (through negligence or carelessness), might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk, is to be binding on my heirs and assigns.

**I further agree to abide by the traffic laws of the State of California and all the rules and regulations set forth for this event, including that I am responsible for providing a bicycle in safe operating condition and for wearing a safety approved helmet.** I acknowledge that an approved helmet is required to be worn by me at all times while riding during these events. Section 1542 of the civil code of the state of California which provides: "a general release does not extend to claims which the creditors does not know or suspect to exist in his favor at the time of executing the release, which if known to him must have materially affected his settlement with the debtor". **There will be no refunds or substitutions allowed if the registered rider is unable to attend or if the event is cancelled due to weather or unforeseen circumstances beyond our control. I voluntarily sign my name evidencing my acceptance of the above provisions. I understand that U.S. Consumer Product Safety Commission approved helmets are mandatory.**
